3. Agreements

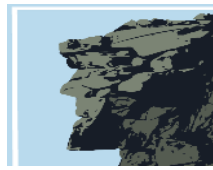

<b>4. Complete Package for small Groups</b>	Collaboration between and among the 3-5 participants to meet at 5 agreed upon dates and time to learn and implement the WALKABOUT Process	\$1,200.00 each participant - includes a copy of the WALKABOUT	5 sessions up to 2 hours in duration over 4-6 weeks
